### **Item 2: RP2120 Cover Paper: Application for the Modification of Specifications for “Enzymatically Produced Steviol glycosides E 960c” as a Food Additive in the United Kingdom to Include Rebaudioside E Produced via Enzyme Modification of Steviol Glycosides from Stevia Leaf Extract. AEJEG/2025/13**

The AEJEG were presented with Application RP2120 for the modification of specifications for “Enzymatically Produced Steviol Glycosides E 960c” as a food additive in the United Kingdom, to include Rebaudioside E (Reb E) produced via enzyme modification of steviol glycosides from stevia leaf extract. This was the first occasion on which the Application was presented to the Members.
