## **Advisory Committee on Novel Foods and Processes (ACNFP)**

**Updated:** 7th December 2022.

**Last meeting:** 16th November 2022.

- The Magnesium-L-threonate application was reviewed for a second time with further information to be requested from applicant.
- The committee was updated on the progress of the CBD subgroup with outstanding areas for discussion identified and notice of upcoming meetings to be arranged.
- A workshop was held to continue discussions from the previous PGT subcommittee meeting further exploring the development of framework for Precision Bred Organisms. Discussion on the development of advice to the FSA and how this could be proportionately reviewed scientifically.
- The Barley Rice protein and Cetylated fatty acids draft opinions returned for final input. The opinion for Barley Rice required minor rewording in some areas and both opinions aim to be published early next year.
- The 2021 annual report was reviewed. The committee were satisfied with the report with minimal input where no further review or clearance would be required. This will also be published soon.
- A discussion for approach to assessment of solvent use for CBD applications was held. The legal frameworks in place were considered sufficient at present. However, the committee invited further review if more information pertaining to any risk, that is not currently addressed by legislation and regulatory requirements, were to be identified.
