FSA Scientific Advisory Committees (SACs) update – December 2015 meeting

This paper provides Members with an update on the work of the Food Standards Agency's Scientific Advisory Committees (SAC) and other items of general interest.

Advisory Committee on Animal Feedingstuffs (**ACAF**) http://acaf.food.gov.uk/

ACAF met in Aviation House, London on 28 October 2015 and the agenda for the meeting included:

Review of Scientific Advisory Committees

Susan Pryde, the lead reviewer for the SACs Review provided an outline of the process and timeframes for the review that was formally launched in September 2015.

• Soy production sustainability – presentation and discussion paper by Ricardo Manoel Arioli Silva

Ricardo Manoel Aroli Silva (Aprosoja) provided the Committee with a presentation on the sustainable production of soy and described the environmental and social management program for Brazilian soybeans.

Presentation and discussion paper by Geoff Brown and Ian Givens -Maximum Permitted Levels of Nutritional Feed Additives – relationship to human dietary intake

Committee Members Geoff Brown and Ian Givens gave a presentation outlining the issue of maximum permitted levels of feed additives, the supplementation of animal diets, and links to animal and human nutrition.

• Antimicrobial resistance - Presentation on the work of JIACRA

Members received a presentation from John Threlfall on the Joint Interagency Antimicrobial Consumption and Resistance Analysis (JIACRA) final report, (published on 30 January 2015). This was the first integrated report by the European Centre for Disease Prevention and Control (ECDC), the European Food Safety Authority (EFSA) and the European Medicines Agency (EMA) analysing possible relationships between the occurrence of antimicrobial resistance in humans and food-producing animals.

• Food Standards Scotland

Dr Susan Pryde from Food Standards Scotland (FSS) provided an introduction to FSS which has now taken over the functions previously carried out by FSA Scotland, but with a broader remit in relation to food safety, diet and nutrition.

• Update on the Review of the Report on On-farm feeding practices

Angela Booth (ACAF Review sub group Chairman) provided an update on the Committee's report on On-farm Feeding Practices.
